Dear Mr. Peer Stiansen,

Honorable Members of the CDM Executive Board,

We would like to express our sincere thanks for offering the possibility to accelerate the forwarding of CERs by fast track forwarding and by advance payment of the share of proceeds as announced in your email dated 19/02/2013. This will undoubtedly bring some relief to deliveries of credits but we would like to bring to your attention the fact that the biggest delays are caused by the lengthy information and reporting check and the review period before issuance.

Hence, we would like to propose that the Executive Board reduce this time line significantly as we are convinced that 23 days for the information and reporting check and 28 days for the review of verifications is not necessary. This is especially the case when verifications are repeated verifications and not first verifications.

It would be of great help if the exceptions offered for the forwarding could be extended to the process before issaunce.
